ONLY Selected menu could be purchased with the meal voucher. Each FnB Tenants will show the menu worth of the value of the voucher.

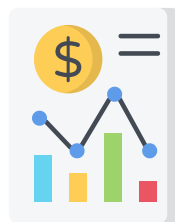

To be considered before ordering the voucher :

1. Your team's schedule.
2. Your team presence at the field outside the schedule.
3. The Operational hour of FnB tenants.
4. If you want to arrange food for your whole team to one tenant, manage your order 6 hour before your team's meal schedule at the sites.

CASHING OUT THE VOUCHER



FnB Tenant submit all the voucher and/or customer receipt at the end of the operational hour, each day.



Fill up the invoice form and submit it to the Barati's finance team. Agreed amount will be signed.



Meal voucher and receipt amount will be transferred to Barati's Finance team via bank to tenant's bank account D+1 after invoice submitted.
